That on 03/05/23 at about 8:30 pm, some unknown persons numbering about 1000 to 2000 belonging to Kuki Community started attacking the undersigned along with family members.

Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all properties of the undersigned were razed to the ground and all the belongings were stolen / destroyed / burned.

Kindly take up an F.I.R. against them as soon as possible for the interest of justice.
