I am to bring to your kind notice that I am a Scheduled Tribe belonging to the Zou Tribe and a resident of A/13, Zone 4, National Game Village, Lamphul PS., VW District, Manipur

That, on the 4th of May.,, 2023 at 12:30 fm. my above said residence (Owned/Rented) was attacked, destroyed, looted and burned by a Group of Meeitei/Meitei radicals.

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned / Rental" House, and premises worth Rupees. Re. 9, 22, 500 [=...(Approx.) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti- tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
