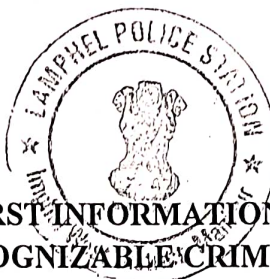

At the very outset, I would like to draw fewline for your information that due to the present situation problem between to community a mob (Meitei) who were gather in the valley area vandalized all our belonging and burnt down our resident at Lamphel ICI Church, P.O & P.S Lamphel, District- Imphal West and property which are kept inside our resident. I along with my family run out in order to save our life and reach 86- CRPF Camp Lamphelpat for our safety.

It is requested to your good office to make entry of my report a Zero F.I.R and issue me the copy of the said report for my reference in future on the destruction of my said vehicle.
