Subject :- Report against Vandalism, looting and arson attack of our house on 04-05-2023 at about 10:00 AM properties situated at Paite Veng, Imphal within Lamphel - PS.

Sir,

I, the undersigned, a victim and refugee taking relief / shelter at Mata, Churachandpur at present have the honour to state the following for your kind intervention and favourable action that, on 4th May 2023 at around 10:00 AM, some unknown Meitei goons armed with deadly sophisticated weapons viz., automatic guns like Ak-Rifles, SLR, machete/ sword, iron rods, etc. came to our Quarter within Lee Faith School Campus, which compelled us to ran for our life. The said Meitei goons forcefully entered our house, vandalized it, looted and thereby burning our house with all the remaining household/ domestic goods inside our house alongwith our two wheeler Honda which is estimated to be worth around Rs. 7,00,000/- (Rupees Seven lakh) approx.

Moveable Properties: (i) All household/ domestic goods.
(ii) 2 wheeler Honda bearing Redg. No. MN01V 2007, Dark green in colour.

Being displaced, I therefore request you to kindly take necessary stringent legal action against the said culprits as per law.
