

We, the undersigned on behalf of the members of **Mary Immaculate Catholic Church**, National Games Village (NGV) have the honour to report the following facts and circumstances of violence meted out to our Church for your kind consideration and early necessary action.

1. That, on **Thursday 4<sup>th</sup> of May 2023 at 11.15 a.m.**, a group of miscreants about 50-60 persons came to our Church all of a sudden and started setting the Church on fire and completely burnt down both the **Church building and the quarter** of Church caretaker (enclosed 2 copies of photos).

2. That, it is the only Catholic Church in National Games Village which came into existence in the year 2004 for the people of all communities viz. **Rongmei, Tangkhul, Lamkang, Pomei, Kuki, Meitei, Anglo-Indian etc.** residing in and around the area and the administration of our Church is under the **Holy Trinity Parish Lamphel**. Presently, we have 56 families / households with 238 members.

3. That, as per record available and maintained by the church, the estimated loss of : 1) Church building 2) Quarter 3) Wooden and Iron Furniture 4) Musical instruments 5) Equipments 6) Accessories & materials for worship service 7) Different types of utensils 8) Solar panel 9) Ceiling fans etc. has come to about **Rs. 48,00,000 (forty eight) lakhs**.
