Sir,

I, the undersigned would like to state a few words for your kind perusal and consideration please.

That on the 04/05/2023 at around 12:30 pm, a mob consisting of Meitei people came to our house at Changangei, Awang Leikai and looted, vandalised and destroyed our property (Viz; Diamonds/Ruby/Gold Ear rings, Chains, Cash, Desktop computer, Laptop, I phone, M/Phone, RO water purifier, Washing Machine, Refrigerator, Microwave Oven, Smart TV, Motor pump, Utensils, Keyboard, Trolley 07 Nos, Costly shawls and clothing items, Godrej Steel Almirah 5 doors, 3 doors, 2 doors, Double Bed 04 nos., Single Bed, Dining Table sets, Sofa Sets, Solar complete sets, 04 nos study table, 02 Nos book self with books, Gas stove with 04 cylinders, Geyser etc.) They eventually burn down my house to cinder along with my Car (Ford Ecosport Regn. No MN02B -1568 Chasis No. MAJAXXMRKAER46759) and two dogs. The approximate cost of our valuable items looted, property vandalised, destroyed and burnt is Rs 1.2 crore.

That the following days, the same group of people looted my compound taking away whatever was left including my Iron gate.

Requesting you to kindly lodge an FIR and take necessary action as per law.
