Subject : Reg. lodging of FIR

Sir,

I the undersigned would like to state a few words for your kind perusal and consideration please.

That on the 04/05/2023 at around 12:30 pm, a mob consisting of Meitei people came to my house at Changangei Awang Leikai and looted, vandalised and destroyed our property (Viz; Diamonds/Ruby/Gold Ear rings, Chains, Cash, watches, Desktop computer, sound mixers, Laptop, I phone, M/Phone, RO water purifier, Washing Machine, Microwave Oven, Smart TV, Speakers, Generators, Geyser, Printers, Scanner, Almirah 5 doors, 4 doors, Double Bed 03 nos., Single Bed, Dining Table sets, 03 Sofa Sets, Gas stove with 05 cylinders, 02 Smart Hub Refrigerators, etc.). They eventually burn down my house (02 storey building) and vehicles (Chevrolet UVA Reg No. MN 01X 1442, Mahindra Scorpio Reg No. MN 02C 0762 and M/Cycle Reg No. MN 01AC 8311) and physically assaulted me and my son. The approximate cost of our valuable items looted, property vandalised, destroyed and burnt is Rs 4.97 crores.

That the following days, the same group of people looted my house taking away whatever was left including my Iron gate, water pumps, water storage tanks, construction materials and many more.

Requesting you to kindly lodge an FIR and take necessary action as per law.
