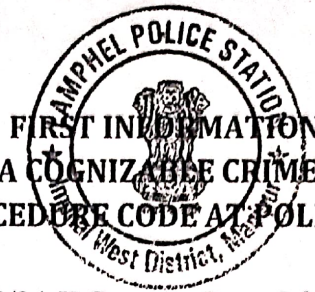

Subject: - Request for lodging FIR against Irom Ratan, aged about 34, S/o Irom Tomba Singh of Sagolband Tera Sapam Leirak, Imphal West District, Manipur.

Sir,

With due respect, I the undersigned would like to state the following few lines for your kind perusal and necessary action thereof.

That, I while was returning after performing my duty on 16th May, 2023 at around 9:40 p.m at Tera Sapam Leirak Nongmaithem Leikai/Tera Bazar, a swift car (offwhite in colour) obstructed my way, as the said vehicle was parked in the middle of the road and I asked the driver of the said car to give me passage for my vehicle and in doing so a few words were exchanged.

That, the said Irom Ratan along with another 2 (two) unknown persons intentionally followed me and drove the swift car onto me with any intention to kill me at Tera Sapam Leirak Nongmaithem Leikai/Tera Bazar and as a result of this attack I was immediately taken to RIMS, Hospital for medical treatment.

In the above facts and circumstances I earnestly request to kindly lodge an FIR against the said Irom Ratan and take up necessary legal action from your kind ends.
