Subject:- Report for Investigation of burning house, looted properties

Sir,

On the 4<sup>th</sup> May, 2023, after noon, around 1000 youths suspected to be "Arambai Tengol" group from the Meitei community, carried guns, ammunitions and other deathly weapons, attacked Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every piece of property.

The following particles they had looted and burnt in my rented house.

1. Gas Cylinder-3 worth Rs. 8000/-
2. Gas Stove worth Rs. 2000/-
3. Kitchen Items Worth Rs. 50,000/-
4. Books worth Rs. 10,000/-
5. Clothing and shoes worth Rs. 50,000/-
6. Blankets and bed sheet worth Rs. 50,000/-
7. Mattres worth Rs. 3000/-
8. Beds-3 worth Rs. 70,000/-
9. Sintax worth Rs. 10,000/-
10. Washing machine Rs. 14,000/-
11. Wooden bench Rs. 25,000/-
12. Chair value Rs. 3000/-
13. Gas box worth Rs. 20,000/-
14. Iron Almerah Rs. 30,000/-
15. Bycycle value Rs. 12,000/-
16. Shoe rack value Rs. 15,000/-
17. Stand Fan value Rs. 2000/-
18. Dining Table value Rs. 5,000/-
