On the 4<sup>th</sup> of May; 2023 afternoon, around 1000 youth suspected to be 'Arembal Tenggol,' group from the Meitei community, carried guns, ammunitions and other deadly weapons attacked the Khongsai Veng, Laipham Khonou. Many of us were killed and injured. So, I and my family fled and hid in different places to save our life. On that same day, after we fled they had destroyed locked door, looted every pieces of our properties i.e. Steel almirah-3, Wooden almirah-3, Wooden Bed -3, Matress-3, Gas Box-1, Sofa Seat -3, TV with stand-1, Gas cylinder-4, Stove-1, Bed Box-1, Washing machine, Fridge, Table-2, Dining table-1, Second Hand Bail-20 sets, Longyi-40 pcs, Mistry instruments etc. Approximately 20 Lakhs in value were lost.

I therefore requested to booked the culprit and take necessary action as per the law of the land.
