On the 4th of May, 2023, afternoon, around 1000 youth suspected to be 'Arambai

On the 4th of May, 2023, afternoon, around 1000 youth suspected to be 'Arambai Tenggol' group from the Meitei community, carried guns, ammunitions and other deadly weapons, attacked the Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every pieces of our properties, burnt down our garage with vehicles and buildings.

Among the houses they have been burnt, all document/certificates were also completely destroyed.
