Sir,

On the 4th May, 2023, after noon, around 1000 youths suspected to be "Arambai Tengol" group from the Meitei community, carried guns, ammunitions and other deathly weapons, attacked Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every piece of my property and burnt my house.

The following particles they had looted and burnt in my house

1. Furnitures worth 2,50,000/-

2. Kuccha Toilet worth 1,00,000/-

3. Creta, EX Petrol- MNO1AW1594. Engine No- G4FLMV263041. Chassis no- MALPA812LMN269871 worth Rs. 13,00,000/-

4. Sintax and bed value Rs. 10,000/-

5. Kuccha House with three room worth Rs. 20,00,000/-
