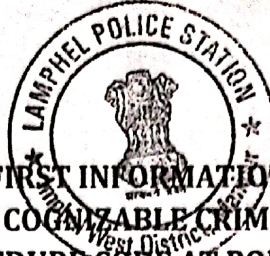

Subject:- Report for Investigation of burning house, looted properties

Sir,

On the 4th May, 2023, after noon, around 1000 youths suspected to be "Arambai Tengol" group from the Meitei community, carried guns, ammunitions and other deadly weapons, attacked Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every piece of property, burnt down my garage with vehicle, and building.

The following particles they had looted and burnt in my four storey building

1. Building- Four storey with fifteen rooms with attached bathrooms and toilets worth Rs. 3,00,00,000/-
2. Gas Cylinder-4 worth Rs. 16000/-
3. Television worth Rs. 50,000/-
4. Gas Stove worth Rs. 10,000/-
5. Almerah worth Rs. 1,50,000/-
6. Kitchen Items Worth Rs. 2,00,000/-
7. Washing Machine worth Rs. 30, 000/-
8. Books worth Rs. 50,000/-
9. Study table and chairs worth Rs. 15,000/-
10. Refrigerator worth Rs. 50,000/-
11. RO Filter worth 25,000/-
12. Clothing and shoes worth Rs. 1,50,000/-
13. Blankets and bed sheet worth Rs. 1,00,000/-
14. Mattres worth Rs. 60,000/-
