Subject:- Report for Investigation of burning house, looted properties

Sir,

On the 4th May, 2023, after noon, around 1000 youths suspected to be "Arambai Tengol" group from the Meitei community, carried guns, ammunitions and other deathly weapons, attacked Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every piece of my property, burnt down our garage with vehicle, and building.

The following particles they had looted and burnt in my rented house

1. Bolero- MN02B9778 worth Rs. 4,50,000/-
2. Jupiter- MNO1Y3668 worth Rs. 40,000/-
3. Gateway Laptop worth Rs. 45,000/-
4. Gas Cylinder-2 worth Rs. 4500/-
5. Flat Television- 42 cm worth Rs. 45,000/-
6. Gas Stove-1 worth Rs. 3500/-
7. Wooden Almerah-1 worth Rs. 1,00,000/-
8. Kitchen Items Worth Rs. 1,00,000/-
9. Washing Machine worth Rs. 15000/-
10. Books worth Rs. 50,000/-
11. Blankets worth Rs. 1,00,000/-
12. Mattres worth Rs. 30,000/-
13. Tables, chairs worth Rs. 1,50,000/-
14. Beds-2 worth Rs. 50,000/-
