Subject:- Report for Investigation of burning house, looted properties

Sir,

On the 4th May, 2023, after noon, around 1000 youths suspected to be "Arambai Tengol" group from the Maitai community, carried guns, ammunitions and other deathly weapons, attacked Khongsai Veng, Laipham Khunou. Many of us were killed and injured, we fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every piece of property, burnt down garage with vehicle, and building.

The following particles they had looted and burnt in my four storey building

12. Kurl on mattresses value Rs. 1,50,000/-
