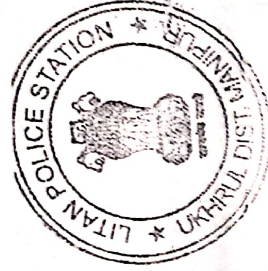

Sir, I have the honour to refer to the subject captioned above and to state that, on the 4th of May, 2023, afternoon, around 1000 youth suspected to be 'Armbai Tenggol' group from the Meitei Community, carried guns, ammunitions and other deadly weapons, attacked the Khongsai Veng, Laiphum Khunou. In order to save our life, we fled and hid in different places. After we fled away, they destroyed locked doors and looted every pieces of our household properties and burnt down even all documents/ certificates completely/ mercilessly.

Details of destroyed/ burnt down items:

1. Recently purchased Activa (Honda) 125 black - in colour.
2. Three Beds
3. Two wooden Almira, 4. 3 Steel Almira,
5. Three Arm benches with cushion.
6. One Kitchen Almira, 7. 2 Bed box
8. Four Gas Cylinders, 9. One refrigerator,
10. One Laptop Dell, 11. Flat TV (LED)

Approximate Value of total losses in Rs. 18,00,000/-

In view of all these, I therefore request you to booked the culprit and take necessary action as per the law of the land.
