House No. 163 (Rent): Fridge, Sofa set, Cylinder Stove set, Washing machine, almiriah-4, Cycle, King Size Bed-2, Dispenser, Dining Table, Dressing table, Bed Box, Jumbo Box 3, Jumbo almiriah 2, Gas Box, Grinder set, Syntex 3, Brite 2 and many valuable items. (Approximately value of total loss Rupees 8 Lakhs)
