Subject: **FIR Report.**

Sir,

On the 4th of May, 2023, afternoon, around 1000 youth suspected to be 'Arambai Tenggol' group from the Meitei community, carried guns, ammunitions and other deadly weapons, attacked the Khongsai Veng, Laipham Khunou, Imphal East. We fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every pieces of our properties, burnt down our garage with vehicles and buildings.

Among the houses they have been burnt, many document/certificates were also completely destroyed.

I therefore request to booked the culprit and take necessary action as per the law of the land.

***Details of destroyed items:***

House No. 33 (Rent): Cylinder Gas-2, Almirah, Bed box, Table, Syntex, Tailor Machine, Cash 26,000/-, Chair - 6, Dining table, Pots, Blanket, Clothing, Washing machine etc.

Approximate value of total losses in ₹: 1,65,000/- ( Rupees One lakh sixty-five thousand)
