It is to inform you that on 3<sup>rd</sup> May, 2023 at around 8:00 pm a group of Meitei Organisation numbering more than 1000( one thousand) suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun attacked my residence at Meitei Langgol Game village (Zone-I) near Tangkhul Church, Emmanuel colony (Zone-I, Game village) vandalised my private residence and looted the following household properties:-

(1). Smart LED TV (55 inches) (2) Washing Machine (8 kgs) (3) Four nos. of syntax (500 Litres) (4) Refrigerator (5) Gas stove with 3 nos. of cylinder (6) One no. of Steel Almirah (7) 4 nos. of wooden sofa seat (8) one no. of wooden bed (5 ft.) with Godrej mattress (5 inch.) (9) one no. of dressing table (10) Five nos. of King size blankets (11) some electronics kitchen items (12) Traditional valuable items etc.

The approximate total cost of items worth is Rs. 20,00000/- (Twenty Lakhs) only.

It is therefore requested to lodge FIR in connection with this incident.


