It is to inform you that on 4th May, 2023 at around 5:00 pm a group of Meitei Organisation numbering more than 1000 (one thousand) suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun attacked my residence at house no. 111 Khongsai Veng, Laiphom Khunou, Imphal East vandalised my private residence and burnt down my private car Celerio B/R No. MN01AS0024 and one Ray scooty B/R MN01C-9331 and looted all my household properties.

The approximate total cost of items worth is Rs. 14,67,000/- (Fourteen lakhs sixty-seven thousand) only.


It is therefore requested to lodge FIR in connection with this incident.
