I am to state that on 3rd May 2023 a communal violence broke out in the state capital of Manipur.

On the next day i.e 4th May, 2023 at my residence at National Game Village Zone 1 near ECA Church Lamphel Pat Sub-Division, PO & PS-Lamphel, District-Imphal West, State-Manipur – Jamabandi enclosed) at around 12:00 noon an unruly mob of around 1000-2000 armed with deadly weapons started gathering and started pelting stones at Game Village Town and totally destroyed my house also.

At that moment I was the only family member present in my house and managed to escape amidst the pelting of stones.

On the same day i.e 4th May 2023 the house was looted and plundered with the following items as listed in the table below. After freely looting and plundering the household items of my residence, my house building worth Rs. 1.5 crore was totally damaged.
