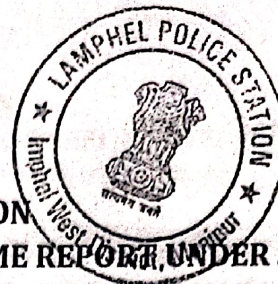

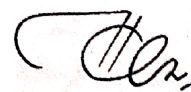

That, on 4th May, 2023 at around 11:00 am a good
number of unknown miscreants suspected to be Aram-

etc. burnt down my residential buildings, furnitures,
School namely MARIO MONTESSORI SCHOOL, with furnitures
and important documents relating to school and village
Activa 1 no. and all my properties located at National
Games village P.O 2 P.S Lamphel-795004, Imphal West,
District, Manipur, bearing DAG No. 83/851, Patta No. 2576
514/3538 (N) Area - 0.0761 Acre 91-Meitei Langat which is
my homestead land. The Value of my homestead land,
these buildings including school, properties damaged,
destroyed or burnt down is estimated to be around
Rs. 1.50/- (Rupees one cores fifty Lakh) Approx.

I could not report the incident to my concerned
Police Station in time due to prevailing law and order
situation of the State.

I therefore, request your good office kindly
take up further necessary action in this regard.
