That, on 3<sup>rd</sup> May 2023 at around 10:30 pm, unknown miscreants suspected to be Arambai Tengol, Kangleipak Kanba Lup. Meitei Leepun numbering about 300-500 burnt down my Carpentry workshop at Langol Phaipijang near Type -II parking, PO & PS: Lamphel, Imphal West District, Manipur bearing License No. IMC/17(5)/17 including tools & machineries, raw materials, finish product, etc. The value of damaged properties is estimated to be about 40 lakhs approx.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary action in this regard.
