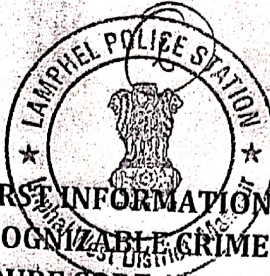

few lines below.

That on the 4th of May 2023 at around 12:30 p.m. at
Emmanuel colony Games Village Zone-I that my husband
Mr. P. Siemcha Gangte was brutally murdered and burnt
to ashes by Akambai Tenggot, Mitei Leepun, Kanglipak
Kamba Lup etc, and we are not able to rescue or
pick his mortal remains at the time due to the inter-
situation of communal feud.

That we were not able to report ~~is~~ on time due to the
prevailing law and order situation in Manipur.

Therefore, request your good office to take up
necessary action in this regard.
