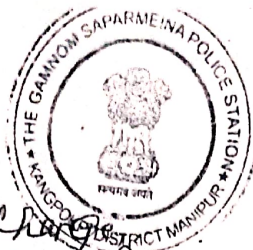

Sir, With due respect, I have the honour to state the following for your kind consideration and necessary action.

That, Sir, on 3rd May, 2023 at around 10.30pm unknown miscreants suspected to be Areambai Tergol, Kangkeipak Kanna Lup, Meetei Kerpun numbering about 1000 attacked my house at National Hamez Village, Zone-1, Near KCC Church, P.O. & P.S. Lamphel, Imphal West District, Manipur and after looting all my properties burnt down my house. The approximate value of properties damaged is estimated to be about 25 lakhs.

That, I could not report the incident to my concerned police station as well as in time due to the prevailing law and order situation.

I, therefore, request your good office to kindly take up necessary action in this regard.
