My name is Thangvendam Hangshing and I am native of Kangchup Chingkhong Village in Manipur. I am lodging this complaint against Arambai Tengol for attempted murder, looting and burning of my house properties and valuable documents. These heinous crimes have left me in a trauma and unsafe in our own State of Manipur.

On dated 04/05/2023 at @ 11:00 am, My house was subjected to a horrific act of vandalism, where miscreants led by Arambai Tenggol broke into my property and looted all of our valuable possessions. These miscreants came to attack me and my family with deadly weapons like Iron rod, Knives and also by holding Arms. The perpetrators set fire to my house, causing extensive damage and rendering it inhabitable. This has not only caused financial loss, but also emotional trauma for me and my family and the loss will not be able to recover for the rest of my life. Now, I am left with nothing as I had to run for my life and had a narrow escape from death. This horrible incident has had a profound impact on our lives, and we feel violated

I urge you to take swift action to bring these criminals to justice. Therefore, I request that you launch a thorough investigation into the matter and bring the
