Sub:- Report of 7 houses burnt properties by mob.

Sir

I have the honour to state that, on 4th May, 2023 at around 11:30 AM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Arambai Tenggol, World Meitei Council (WMC), Meitei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC), numbering about 1000+ members carrying sophisticated weapons like AK rifles, 303 Rifles, SBBL, Pistol, Mototov, etc with vehicles forcefully entered in my village located at Kangchup Chingkhong, Kangpokpi District. They looted all valuable and vandalized houses, moveable properties and leaving us homeless. The approximate value of lost and destroyed are to be about 4Crores 30lakhs.

I Therefore, request to kindly registered a regular case and take necessary legal action according to law.
