I have the honour to state that on today i.e 28/05/2023 at 1:30 am some unknown arms Kuki Militants came down from the hill side towards Phayeng Ching Khunou (Freedom Hills) and open fire by using sophisticated weapons and attacked a Sentry post which was set up by the Voluntary Civilian Vigilante group of Phayeng Ching Khunou located at Freedoms Hills (Phayeng Ching Khunou). During the attack, my elder brother namely Angom Basanta Singh (28) S/o A. Ingojao Singh of Phayeng Ching Khunou was succumbed at the spot due to bullet injury and one Angom Premjit Singh (27) s/o A. Ingo Singh of Phayeng Ching Khunou sustained bullet injury on his person and evacuated to Hospital for further Medical Treatment.
