

Shanta Singh of Lamlongei Mayai Leikai received bullet injury on his left leg while he was standing at the Abalog Bridge along Phayeng Abalog Canal Road which the bullet was coming from the hill side direction and suspected to be shot by Kuki militants using sophisticate weapon. As a result of which the injure person got serious injuries and evacuated to Hospital for further Medical Treatment.
