Today i.e. 02/06/2023 at 3:00 pm receive reliable information that on the same day at about 2:20 pm some armed Kuki Militants who were hiding at K. Songlung, Heinom Veng & Tuikul village area of KPI Dist. border led to Imphal West Dist. opened fire using sophisticated weapons towards the villagers of Phayeng and Kangchup area and there was continuous exchange of fired and retaliation by the combine team of CDO/IW, 5 MR, Civil Police TML personnel and CAPF team deployed at Phayeng and Kangchup area led by Addl. SP(Ops)IW under the overall supervision of SP/IW Dr. S. Ibomcha Singh, MPS to flux out the Kuki Militans. As a result of which some civilian of the nearby area sustained bullet injury on their persons out of the bullet fired out from the side of the Kuki militants having sophisticated weapons and the injured persons were evacuated to hospital for medical treatment.

Hence a Suo-Motto case has been registered under FIR No. 541(6)2023 LSG-PS U/S 326/307/506 IPC, 25(1-B) A Act & 16 UA(P) Act for investigation.
