Today i.e 10/06/2023 at 2:40 pm receive a reliable information that on the same day at about 2:30 pm while conducting area domination, patrolling & checking by the combine team of C-45 BSF led by Assistant commandant Belavalekar Vinayak Pandurang, Inspt. Anilchandra Mutum and SI Th. Samarjit Singh of CDO Lamsang led by Dysp. Ops./ Rk. Eden Singh (MPS) from Kangchup Chingkhong to K. Songlung village giving information to OC/ Kangchup PS, recovered two nos. of improvised country made pipe guns from 2 (two) bunkers on the northern side of K. Songlung Village which were used by the Kuki militants and the same articles were seized at 3:50 pm from the spot of the same day by observing formality. And also dismantled 4 (four) bunkers.

Hence a Zero FIR has been registered on suo-motto under FIR No.0 (6)2023 LSG-PS U/S 153A/506 IPC & 25 (1-C) Arms Act & 16 UA(P) Act.
