Sir

With due respect, I have the honour to state that on 17/6/2023 at @ 10:30 pm about 10 (ten) rds of assault rifle were fired by the suspected Kuki militant/Miscreant from the western side jungle of K. Songlung village towards the sentry post stand at Little Seed School, Kangchup Chingkhong where there is I/W Civil Police and 184-F Coy CRPF were on duty. Immediately, alerted the post and informed senior Officer and retaliated from the personnel toward the side of suspected kuki militant/miscreant was going on thereafter OC/LSG-PS team CDO/IW bullet 1 Mike 57 team led by Dysp (OPs) RK. Eden Singh MPS arrived at the site and further ensued intermittent counter firing from the state force side in order to flush out the Kuki Millitant/Miscreant from the area lasted till 1:30 am of 18/6/2023. No casualty received as a result of the incident on the part of the personnel and 30 (thirty) rds of AK 56 , 23 rds of .303 rifle, 2 rds of INSAS and 16 rds of SLR were fired out from the service gun by the personnel for self-defense and protection in the dark.
