With due regard, I have the honour to state that on today ie 22/06/2023 at @ 6:30 pm while a combine team of 5th MR and civil police Tamene long personnel were on patrolling, Frisking and checking duty from Kangchup Kharang towards Apunlok canal road in between Phayeng and Kadangband Singda, some 4/5 rds of Assault Rifle were fired out by some suspected to be Kuki mititants/ miscreants from the hill side of Tuikul and Geljang area of Kangpokpi district towards the patrolling party so as to show their presence and domination in the area, thereby the patrolling party and nearby Civil police team of Imphal West station at Little Seed School, Kangchup Chingkhong also retaliated towards the gum shots coming from Hill side from their service guns for their self defence and protection and also to flux out the suspected Kuki miscrients/millitants from the area.

It is also submitted that the personnal of 5 MR engaged in the incident have fired out 25(twenty-five) rounds ammunitions of AK-47, 17(seventeen) rounds ammunitions of INSAS rifle and Civil team of Imphal West Station at Little Seed, Kangchup Chingkhong fired out 12(twelve) rds ammunitions of INSAS, 36(thirty-six) rds ammunitions of SLR and 13 (thirteen) rds ammunitions of 303 rifle and no casualty is received or reported during the incident.
