



Subject - Request for registering FIR.

Sir,

This is to inform you that on the 4<sup>th</sup> of May 2023, around 11 AM, a Meitei mob numbering over seven hundred (700) attacked my village. The mob consisted of members of neighbouring Meitei villages on the frontline, who were backed up by members of the Arambai Tenggol wearing their trademark black T-shirts, along with state police commandos bringing up the rear. They were armed with rifles and sophisticated automatic weapons and shot indiscriminately with an intent to kill.

We were forced to flee our village. My house was burnt, and all possessions were looted including washing machine, TV, fridge etc.

I therefore humbly request your good office to kindly take necessary action in this regard.
