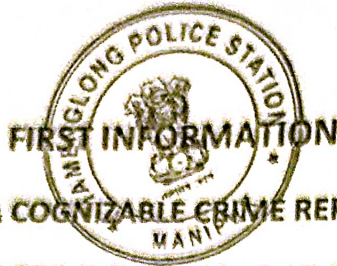

That on dated 04th May, 2023 at around 02:30 pm at Kangchup Chingkhong Kangpokpi District cross firing took place and two persons were severely injured namely [1] Ngampu Khongsai [22] years s/o Helen Khongsai of Kangchup Songlong P.O and P.S- Lamsang, Kangpokpi District Manipur and [2] Vanlalmuang Khongsai [20] years s/o [L] laithangrou Khongsai of Kangchup Shonglong P.O and P.S- Lamsang, Kangpokpi District Manipur. Further they were evacuated to District Hospital Tamenglong for medical treatment.
