Report against criminal intimidation, vandalism and arson attack on Evangelical Churches Association and all its properties that took place on 3rd May, 2023 at around 5:00 PM at Taothong, Imphal West within Lamsang-PS.

Sir,

I, the undersigned, on behalf of the Evangelical Churches Association have the honour to state the following for your kind intervention and favourable action that, on 3rd May 2023, at round 5:00 PM, our said Church standing upon a land under Patta No. 98 / 863 covered by C.S. Dag. No. 380/870 Block 95 - Taothong, alongwith all the properties kept inside was attacked, vandalized, completely destroyed and burn down to ashes, by heavily armed unknown miscreants/ goons from the Meitei community. The estimated value of all the moveable and immovable property destroyed, vandalized and burnt is estimated to be worth approximately Rs. 5,00,000/- (Rupees Five Lakh) only.

That, as all the said Meitei goons/ miscreants are roaming around openly armed with deadly weapons, all the Church members ran in fear of their life, and they being displaced, I in the capacity of the Executive Director of the said Church, file this report at the nearest Police Station and therefore, request you to kindly take necessary legal action against the said culprits as per law.
