



Subject : Report

Sir,

With due respect, I have the honour to report that, on dated 02-06-2023 at around 5:00 pm, group of miscreants belonging to Meitei community numbering more than 500 people holding deadly weapons attacked our village i.e Kangchup Chingkhong Village, Kangpokpi District. In the incident, the miscreants vandalized my House (House No. 11), looted properties and finally burnt down my house and all household properties into ashes.

List of properties looted and burnt down with estimates(approx.) are as under:

1. 1(one) Pucca building and toilet - Rs. 30 Lakhs.
2. Furnitures - Rs. 6 Lakhs.
3. Electronic items i.e Refrigerator, Washing Machine, Desktop, LED TV, Inverter, & Battery, Solar Plate, Microwave Oven, Rice Cooker, etc - Rs. 5 Lakhs.
4. Construction materials, Wooden Planks, Roofing Materials, Cement, Sand, Iron rod - Rs. 7 Lakhs.
5. Household items i.e Utensils, Gas Stove, Pressure Cooker, Cylinder, Rice paddy stock, Flower pots - Rs. 4 Lakhs.
6. Clothings, Books and other miscellaneous items - Rs. 5 Lakhs.

The approximate value of destroyed/looted/burnt properties is estimated to be about Rs. 57,00,000/- lakhs (Rupees Fifty Seven Lakhs) only.

I therefore kindly request you to take necessary action in this regard.
