

Sir,

With due respect, I have the honour to report that, on dated 27-05-2023 at around 8:30 am, group of miscreants belonging to Meitei community numbering more than 500 people, by holding various deadly weapons attacked our village i.e Kangchup Chingkhong Village, Hinnom Veng, Kangpokpi District.

In the incident, the miscreants have vandalized my house, looted properties and finally burnt down my house and all left behind household properties into ashes. Some of my looted and burnt down properties are Furniture items, Wooden Planks, Roofing Materials, Utensils, Gas Stove, Pressure Cooker, Cylinder, Rice paddy stock, all Clothing and Garments, Important books and documents and others.

The approximate value of destroyed/looted/burnt properties is estimated to be about Rs. 30,00,000/- lakhs (Rupees Thirty Lakhs) only.

I could not report the incident to my concern Police Station as well as in time due to the prevailing situation in the state.

I therefore kindly request you to take necessary action in this regard.
