Today i.e 9/07/2023 at 9:05 pm receive reliable information that on the same day at about 9:00 pm some armed Kuki Militants/miscreants who were hiding at K. Songlung, area of Kangpokpi Dist. opened fire using sophisticated weapons towards State force/Civil Police team of Imphal West who were stationed at Little Seeds School, Kangchup thereby the personnel of State force deployed at the area ensued an exchange/counter firing and retaliation going on against the armed Kuki militants/miscreants to drive them out from the area.

Hence a Suo-Motto case has been registered under FIR No. 564(7)2023 LSG-PS U/S 400/307/506/34 IPC, 25(1-B) A. Act for investigation.
