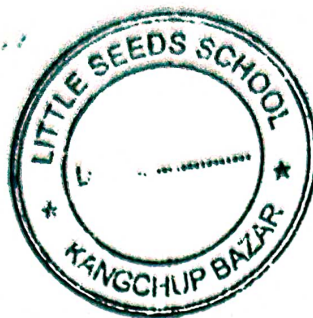

Subject :- Humble a complaint petition praying to lodge an FIR Case and placing in Record for demolition broken, stolen of articles of the "Little Seeds School settled at Kangchup Bazar along with dwelling resident by the Chin Kuki Militant along the parties of Kukis settled in the CCPur District now remained in Suspension of Operation which was unexpectedly held & took place on moved on 4th May 2023 at about 11:00 a.m. to through night on the day.

Sir,

I, Chairman of the said "Little Seeds School" along with the owner of the said building the under signed have the honour to lay the following fact points for your kind consideration and taking necessary action on the above referred to

- 1) That, I am now a Chairman and owner of the said school & building constructed & established for student's boarding at the said Kangchup Bazar for the last about 10 (ten) years.
- 2) That on an unexpected moment on 04/05/2023 at about 11:00 a.m. to through night the aforesaid joined Militant of Kukis of CCPur along with the Chin-Kukis Militant who were intruded from the Myanmar Country unguarded moment cut and run at the said school and dwelling resident now utilizing as school & Boarding of student started to demolish, breakout stolen & other ornaments and cashes from the said school building with the asking and informing with a single words.
- 3) On the day of the said occurrence I along with the staying student at the Boarding have been escaped and fled (run) away for fear of formidable occurrence from the place to the village of Phayeng in order to save our life and took rush as the "part of Relief Camps".
- 4) In my aspiration the said school and building have likewise seen as a place of ground & pasture place.

5) As such, the following things & articles and valuable ornaments & Gold & Chases which were stolen and partly broken at the instant are :- , ,

7) I could not report well in time due to communal issue in between two communities' i.e Meitei and Kuki.
