Subject: Report.

Sir,

I have the honour to state that on 21/07/2023 at 10:20 pm some Kuki Militants/Miscreants have attacked by firing out several rounds using sophisticated weapons towards the direction of 9th IRB (Sports) team deployed at the Koutruk Apunba Club Building from above the Hill side Jungle of Koutruk Range along the Bethel village and immediately ensued counter firing and retaliation from the side of State force from their service rifle deployed at Koutruk and nearby 7th MR, Civil Police I/W and SDRF team deployed at NSUI Campus Koutruk so as to protect life and property. Further, sporadically counter firing retaliation lasted till 5:00 am of 22/7/2023 and the said Militants/Miscreants have used lathode bombs towards the State forces during the attacked. However no causality was received on the part of the security personnel as a result of the incident.

Further the undernoted personnel have fired out the undernoted rounds of ammunition and their details are as given below.
