Sub: First Information Report.

Sir,

- On 3rd May 2023 at approx 1800hrs Assam Rifles was requisitioned by the Govt of Manipur received through DC KPI for Aid to Civil Authority.
- 2. On 28 May 2023 during night at approx 0230hrs onwards, while operating in aid to civil authority, own troops had to resort to firing in the Air to disperse unidentified personals/ANEs. The details of incidents are in succeeding paras.
- 3. Input was received regarding two casualties at Phayeng village that occurred firefight between Village Defensive Force (Meiteis) and Kuki miscreants. On information Assam Rifles columns rushed to evacuate the casualties at Phayeng village. Meanwhile Manipur Cdos had reached Phayeng village and were firing towards Kuki miscreants& large mob had gathered at Phayeng village and were not allowing own columns to move ahead to evacuate the casualty.
- 4. 'While returning back mob in possession of lathis and other crude incendiary materials blocked the way and also tried to vandalize own vehicles which was stopped by own column at Singda Kuki.Large mob of approx. 1000 to 1500 individual blocked the ingress and egress routes to Kuki dominated villages. Protesting women, Meira Paibis (Meitei) blockade the routes.
- 5. Own convoy and troops were halted and not allowed to move ahead. Collectively the mob coming from multiple directions led by Manipur Commandos reached Chinkhong Junction & Twikhon Junction.
- 6. The irate mob started burning houses. Kuki groups retaliated with fire and heavy fire fight commenced between the mob (Meitei and Kuki).
- 7. IS (Internal Security) Duty columns of Assam Rifles were launched to contain the situation, due warning was given by own troops to disperse the crowd. Thereafter, own columns warned them in vernacular, English & Hindi language and preventing them to move further. Sensing grave danger to life of innocent civilians & insurmountable threat to Govt property, controlled Fire in air was carried out by own column as last resort to disperse the unlawful assembly after adequate warning as legally mandated thereby, controlling the aggravating situation in time saving precious lives and preventing any collateral damage.
- 8. Assam Rifles columns carried out search of the area after the controlled fire in air & dispersal of crowd to look for injured persons and provide medical aid & evacuation. There were no injured person at the location. NO casualty of civilians reported.

9. You are requested to kindly file an FIR against unknown armed rioters and investigation the incident for attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorised usage of fire arms and ammunition to include automatic weapons.
