Respected Sir,

I, the undersigned, have the honour to lay the following few lines for your kind perusal and necessary actions:

1. That, vide order dated 13<sup>th</sup> May, 2023, no. DLSA/IW/18/2023/230 we, the Front Office functionaries, PLVs of Legal Aid Clinic of Phayeng visited the affected areas having relief camps at Tairenpokpi Chingtaba and Phayeng Ching Khunou respectively under Imphal West District, Manipur on 16.05.2023 and 17.05.2023 at about 8.00 a.m.,.
2. That in the said relief camps at Tairenpokpi Chingtaba, 60 families were found taking shelter including 77 male, 80 female and 120 children and at Phayeng Ching Khunou, 17 families were found taking shelter including 36 male, 31 female and 17 children due to the anti-nationals and anti-social elements by the Kuki Miscreants.
3. That on the intervening night on 4<sup>th</sup> day of May, 2023, the Kuki miscreants at around 09:30 p.m. attacked the villagers of Tairenpokpi Chingtaba and Phayeng Ching Khunou by pelting stones, through slingshots and firing sophisticated guns upon the above mentioned villagers.
4. That the victims narrated that the real results behind the Kuki Miscreant's sudden assaults are not known to them. As such there has not been any reason in the past for them to attack them. Such cowardice act of the Kuki miscreants by firing sophisticated rifles for no known reason has left them in a state of unending fear of psychosis. Further on 5<sup>th</sup> day of May, 2023 at around 03:30 a.m. till 06:00 a.m. the Kuki miscreants in camouflage fatigue armed with sophisticated assaults rifles started firing upon them. As such the villagers have fled from their village and taking shelter in the above noted reliefs camps till date.



5. That the said 77 families were taking shelter in the said relief camps due to the threat to their life by the Kuki Miscreants. The condition of mental and physical deterioration is also prevalent in almost all of those who have stayed behind in the villages.

In this respect they prayed for your kind intervention at the earliest help and bring about a state of normalcy in the village and also to register FIRs in this regard at the earliest for the ends of justice.
