Sub: Request to take up necessary legal action against
the firing of Automatic Rifles at Singda Kadangband Part
by suspected Kuki militants.

Dear Sir,

With due respect, I would like to report that several
rounds of Automatic Rifle bullets were fired upon our village
viz. Singda Kadangband Part-I on the night of 25th August,
2023 at around 10:30 pm by suspected Kuki militia militant
from Kangchup Geljang Village side. The firing caused damage
to the properties of two villagers of Singda Kadangband Part.

(1) One round of bullet hit the wall of the residence
of Bedajet Hodan (39Y) S/o. H. Birachandra Singh and
the projectile of the bullet was found inside the house.
Another 6 (six) rounds of bullet hit the residence of
Sorbam Punshiba Moirangcha (36Y) S/o. S. Indrajit Meitei of
the same village and 2 (two) projectile of bullet were found
from the residence. Fortunately, no villagers were injured
in the firing.

I, therefore, on behalf of the villagers request
to take up legal actions regarding the incident.

For your convenience, images of the damages caused
by the firing and the projectiles found were enclosed
herewith.
