## Properties looted items with the value of amount:

- 1. Grass Cutter Machine- Rs, 9000/- (Rupees Nine thousand)
- 2. Washing Machine Rs, 16,000/-(Rupees Sixteen thousand)
- 3. Laptop (Sony Vio) Rs, 80,000/- (Rupees Eighty thousand)

Total - Rs, 1, 05,000/-(Rupees One lakh and five thousand) only.
