Sir, With due regard, I would like to state that today, i.e. 8th Sept '23 Friday, @ 11.30am, our Koutruk village was attacked by well armed Kuki Militants using sophisticated long-ranged weapons from three directions from western side of Koutruk Hill range. During the attack, a girl identified as Ningthoujam Tina Devi (15) D/O N. Bokai Singh of Koutruk Mayai Leikai was hit by bullet fired from Kuki Militants, on her left foot while she was at home and immediately taken to Hospital. Likewise, several houses of our village, around 30/40 houses were also hit by bullets fired by Kuki Militants, causing damage/destruction etc. This is an act of cowardice of Kuki Militants and a life attempt to the innocent villagers of Koutruk, creating a turmoil to the village and fear of being attacked anytime. The Kuki Militants even fired and attacked on the State forces & central forces, BSF stationed at Koutruk for the security of our village, in which they also retaliated to save the village of Koutruk. This kind of attack has been very frequent and as a result, the villagers are of great fear of being attacked anytime.

It is therefore, submitted for favour & taking necessary legal action on the incident.
