Sir,

With due respect, I the undersigned would like to lay down few lines before you for your kind consideration and necessary action.

On the 4th May 2023 at around 11 am, unknown miscreants belonging to Meitei community numbering more than 1000 people suspected to be members of Arambai Tengol, Meitei Leepun and other have attack our village i.e. Kangchup ^{Chingkhong} village under Kangchup Geljang Sub-Division by holding deadly weapons including automatic Rifles and Bomb. The miscreants have ransacked and burnt down my House and all properties like furnitures, Kitchen items, clothing, Barn, important documents, Grains and Rice, poultry farm and domesticated animals and other properties inside the house. The estimated value of properties lost, ransacked and burnt down by the miscreants is estimated to be about Rs. 40,00,000 (Rs. 40 lakhs) only.

I, therefore request you to kindly take necessary action in this regard for which I shall remain ever thankful to you.
