Sir,

I, Hoineichong Touthang w/o Mangjalun Neishiel, a resident of Kangchup Chingkhong would like to inform that on 04.05.2023 at around 11 a.m. the Meitei mob in thousands came to our village by bulletproof vehicles, trucks and all sorts of vehicles and some on foot attacked our village and set on fire the houses on the lower side/part of the village. As such, all the villagers fled from the village and took shelter at the Kangchup AR camp as there was strong apprehension of attack on our life and property. Thereafter in between 16th-18th May 2023 my house which was situated on the upper side of the village which was left unburnt was vandalised and looted. I along with my other villagers witnessed the vandalising and looting from distance.

I, therefore, request you to kindly register my complaint.
