Sir

As endorsed vide GD. Entry No. 24/LSG-PS/2023 dtd. 5-11-2023, I have conducted a concrete enquiry on the missing report lodged by Maibam Hemanta Singh (45) S/o M. Tomba Singh of Akham Awang Leikai.

During the enquiry it is revealed that the missing person namely:-

- (1) Avinash Maibam Singh (16) S/o M. Hemanta Singh of Akham Awang Leikai, Imphal West.
- (2) Ningthoujam Anthony Singh (19) S/o (L) N. Sunder Singh of Akham Awang Leikai- went out from their home on 05/11/2023 at about 9:10 am on a JAWA motorcycle bike Black in colour Bearing Regd. No. MN01AN-3387 towards Awang Sekmai to meet their friends and didn't come back home.

During further enquiry with the help of OC-Sekmai-PS check some CCTV footages fitted along the NH-102, CCTV footages shown that the duo have crossed Shantipur village under Sekmai-PS on 05/11/2023 at about 10:30 am and the further Gamgiphai village under Kangpokpi-PS and didn't returned back till date, their Mobile Phones Bearing No. (1) 6009682218 belongs to Avinash Maibam Singh (16), (2) 9233470783 and (3) 8837363123, both the nos. belong to Ningthoujam Anthony Singh (19) shows its locations in Senapati area.

It is strongly suspected that they are suspected to have been abducted by Unknown suspected to be Kuki armed militants KRA (U) Cadres from an unknown place and kept concealed for unknown reason at unknown place.

Hence, an immediate registration of a regular FIR and conduct investigation is highly require to rescue them.
