I have the honour to report you that today i.e. 07/11/2023 at about 7:30 am the Gram deployed for Naka duty has detained one Bolero b/Regd. No. MN03p/7773 white colour at Kangchup Chingkhong. The Bolero, white in colour was carrying five individuals i.e. 2 woman and 3 men. It was on its way from Churachandpur to Leimakhong and he took a wrong route. In the meantime, a large and enraged mob of Meitei confronted forcibly took away took four individuals suspected to be of Kuki Community. But one them was escaped from the mob. it is also learnt that one of them was later found rescued by the security with injury on his person. Identities of the individuals' couldn't known. A strong combined security team conducted men hunt operation around neighboring villages and suspected routes to rescue them but couldn't found them.
